OBSESSION WITH ABORTION AND POPULATION CONTROL IN LIBERALS' FOREIGN POLICY

On June 6th, 2017, the Minister of Global Affairs (formerly Foreign Affairs), Chrystia Freeland, gave a speech setting out Canada's foreign policy under Prime Minister Justin Trudeau's Liberal government. In her speech, Ms. Freeland falsely stated that the U.S. is withdrawing from its international responsibilities. This is totally wrong. U.S. President Donald Trump simply requested a more equitable contribution from other countries, which merely amounts to a re-definition of a U.S. continued assumption of its onerous leadership burden. Ms. Freeland should have paid attention to what President Trump actually said.

Because of Ms. Freeland's misunderstanding, she has concluded that Canada must now step into the breach with "hard power". This is absurd. Our military weight doesn't really count for anything internationally. For example, in 2016, the U.S. spent \$611 billion on its military and Canada spent just \$15 billion. We don't even own an aircraft carrier! Ms. Freeland's comments are like Mighty Mouse standing up and flexing his muscles. Ms. Freeland pursues her fantasy because the government plans to invest billions to beef up our military from \$18.9 billion this fiscal year to \$32.7 billion in 2026-27. There is no hint as to where this money will come from. In fact, the Liberals plan to spend \$553 billion on the military over the next 20 years! This is to presume, of course, the Liberals will still be in power at that time. It's a pretty safe bet, under the circumstances, that the Liberals will not likely have to answer for their grandiose military fantasies.

What is even more disconcerting about Ms. Freeland's speech is that she said that Canada's foreign policy is to uphold "Canadian values", and then goes on to state that these values include feminism and abortion. Those may be her and Trudeau's values - but Canadians are not that mixed-up! This is not to suggest that all Canadians are pro-life, but most Canadians, unlike Trudeau, are able to grasp the fact that offering abortion and population control as a solution to Africa's problems is not too sensible.

Ms. Freeland's exact words were:

It is important, and historic, that we have a prime minister and a government proud to proclaim ourselves feminists. Women's rights are human rights. That includes sexual reproductive rights and the right to safe and accessible abortions. These rights are the core of our foreign policy.

To that end, in the coming days, my colleague the Minister of International Development and La Francophonie will unveil Canada's first feminist international assistance policy, which will target women's rights and gender equality. We will put Canada at the forefront of this global effort.

TRUDEAU'S OBSESSION WITH ABORTION

What's with Trudeau's obsession with abortion? It seems that he has a strikingly limited intellectual capacity to understand issues—including abortion. He seems only to grasp the "progressive" chants of the day on abortion, such as "a woman's right to control her own body", etc. etc. He clearly doesn't have the ability to critically analyse the issue, to grasp any understanding of the humanity and dignity of the unborn child, and the implications to society of their massive slaughter.

Instead, his government has locked itself into a twisted ideology that has become its obsession. His government is seriously and continuously spending millions of tax dollars to further its obsession to entrench reproductive control in Third World countries, especially, Africa. This has, according to Freeland, "become the cornerstone of Canadian foreign policy". Trudeau and his government seem unaware of the many global injustices that exist at present, such as female infanticide, female genital mutilation, lack of women's rights to education and genuine health care needs, including maternal and infancy care. His cabinet doesn't seem to grasp the fact that health care includes medicine, vaccinations, nourishment and clean water. Doesn't this government know

that there is an impending famine in parts of Africa? Doesn't Trudeau realize that he is ruthlessly trying to impose his own personal values on family oriented Africa, when, at the same time, he is ignoring Canadians' opinions on the matter?

Instead, the federal government has unveiled what it calls "Canada's First Feminist International Assistance Policy" with plans to eventually ensure that at least 95% of the country's foreign aid be provided to "improve" the lives of women and girls by providing "reproductive rights" (abortion) and contraception.

Development Minister Marie-Claude Bibeau, at a news conference on November 26, 2015, stated, "Contraception and even abortion is only a tool to end poverty". Doesn't she realize that poverty, rather than the population, should be eliminated by many other alternatives, such as access to education and the use of modern technology?

Trudeau and his Liberal government have committed the taxpayers' money to his personal obsession.

- In March 2017, the government pledged \$650 million for abortion and contraception, including funding campaigns to make abortion legal in countries where unborn human life is protected by law;
- In July, 2017 the Liberal government announced a grant of \$97 million to the Democratic Republic of Congo for abortion, which is illegal in the Congo; doesn't Trudeau know that 922,000 citizens of the Congo fled their homes last year due to a long running conflict between various rebel groups there? Doesn't Trudeau know that the Congo is in the midst of a political and economic crisis, and that it requires help, not abortions that this country never requested or desired?
- Also announced was \$20 million in funding to the notorious U.S. Clinton Foundation for reproductive control in Nigeria, aimed at young women and adolescent girls. This foundation was at the heart of the cash-for-access scandal that dogged Hilary during her failed bid for the U.S. presidency.

Certainly, Africa needs Canadian foreign aid, but the last thing it needs is what Trudeau is thrusting on Africans. Trudeau's arrogant actions are cultural and racial Imperialism just like some actions of the old colonial masters.

Trudeau's limited understanding of his role in developing countries is an embarrassment to Canadians. His lack of knowledge and understanding of the world around him is a tragic reminder that he is ill-prepared to be Prime Minister.

Minister of Global Affairs, Chrystia Freeland, hypocritically stated, in her June announcement on Canada's new foreign policy, that "it is clearly not our role to impose our values around the world". What precisely then is she doing? Is it possible that she and the Trudeau government aren't thinking at all?

WORLD WIDE PETITION AGAINST TRUDEAU'S OVERSEAS FUNDING OF ABORTION

When the Trudeau government announced that abortion funding would be "the core of Canada's foreign policy", and then announced a grant of \$650 million to fund abortions in foreign countries, particularly Africa (see article above), REAL Women of Canada joined with the World Congress of Families (WCF) to draft an international petition against these policies. 
The petition was distributed internationally by *CitizenGo*, a community of active citizens who work together, using online petitions and action alerts as a resource to defend and

BOOK REVIEW: 'PIERRE ELLIOTT TRUDEAU'S GREAT BETRAYAL'



PIERRE ELLIOTT TRUDEAU'S GREAT BETRAYAL

By: C. Gwendolyn Landolt, LLB and Patrick Redmond, PhD

Published by The Interim Publishing Company, 2017 217 pages.

For those who have championed the legal rights of unborn children in Canada, this book is a powerful record of their valiant attempts to include pro-life amendments to diminish the harm in Pierre Elliott Trudeau's Omnibus bill in 1969, and his flawed Charter, when repatriated to Canada in 1982.

Appropriately titled Trudeau's betrayal, the book is essential reading for the army of new recruits to the pro-life pro-family movements in Canada, and around the world. Its 240 endnotes, extensive sources, bibliography, references to publications and websites, and comprehensive index, open the door onto a world rich in heretofore hidden information. Excerpts from UN declarations, Church documents and parliamentary debates help clarify the issues at hand.

CHARTER MYTHS SHATTERED

The book shatters popular Charter mythology with facts. Predictions that exclusion of the unborn in the Charter would not lead to abortion on demand can be viewed side by side with warnings to the contrary from pro-life Canadians. Key quotations from Prime Minister Trudeau, Justice Minister Jean Chretien, the Ministry of Justice, Members of Parliament, legal advisors, medical associations and human rights advocates clearly reveal the battle fought to ride the wave of change against Judeo-Christian traditions. Pre-charter times were inclusive of the unborn, the family, property rights and the supremacy of God. The book does not spare deserved criticism of weak religious leadership, juxtaposed with strong religious statements from well-informed clergy.

BEHIND THE MEDIA STORYLINE

In contrast to a character worthy of media adulation, Trudeau's flawed humanity is revealed in choice quotations: "If I found in my own ranks that a certain number of guys wanted to cut my throat I'd make sure I cut their throats first." "...the shameful incompetence of the average Liberal MP from Quebec was a welcome asset to a government that needed no more than a herd of performing donkeys to file in when the division bell rang." "The party of the people —socialism, communism—will eventually come out the winner."

The book reveals how the Liberal government deceived powerful Canadians who didn't understand that the Charter would transfer power from Parliament to the courts. However, it did not fool Canadians informed by the pro-life network. Thinking themselves progressive, Liberals ignored scientific progress while Campaign Life and Toronto Right to Life built their defense of the unborn on the latest scientific facts.

Previously unpublished correspondence between pro-life advocates and elected officials in Canada and the United Kingdom, and clergy representing various religious bodies, uncovers the behind-the-scenes action, with names fearlessly revealed. A bright light is shone on those in favour and those opposed.

Pro-life pioneer Gwendolyn Landolt, warned: "abortion on demand has been locked into the proposed new Charter of Rights," but few would listen. She also predicted the loss of special recognition for women in employment, equality with men regardless of physical difference leading to combat duty, loss of parental rights over minors, homosexual marriage and adoption, loss of property rights, and more. She wrote in 1981 "Under the Charter of Rights, Canada officially becomes a secular state with government being all powerful and the source of all 'justice' without resorting to a Higher Being."

COURT SUPREMACY OVER ELECTED PARLIAMENT

Improper use of evidence in the Morgentaler case is exposed. The Cardinal Carter reversal on the Charter is parsed. Feminist taxpayer funded complicity is noted. We are reminded of Trudeau's creation of a centralized dictatorial Prime Minister's Office and 114 agencies and commissions working independently of Parliament. The truth about Prime Minister Mulroney's Conservative Bill C-43 on abortion is put on record. Tabled are REAL Women of Canada's court interventions for the unborn every time Court Challenge Program funded activists tried to bypass Parliament via the courts.

The authors opine that Trudeau and Chief Justice Bora Laskin "thought MPs were impressionable, uninformed and ignorant, and the elite, knowledgeable judges were better able to make decisions on human rights." They call the prolife battle with Trudeau a deadly game of poker and claim that his imposition of constitutional changes was carried out through a bloodless revolution. They point out that many capable legal minds did not foresee that the Supreme Court, given supremacy over Parliament, "could and would wield the Charter as a bludgeon to eliminate traditional values in Canada by declaring some laws as being unconstitutional, not only in regard to abortion, but also on the issues of physician-assisted suicide, prostitution, traditional marriage, medical marijuana and drug-injection sites, religious rights,

etc., to name a few of the values tossed aside by the Court in subsequent years."

DID YOU KNOW?


Charter and Constitution aficionados will appreciate newly revealed factoids in this judicial and Parliamentary drama over life and death: What is the link between the constitutional debate and the Rebellion of 1838 in Upper and Lower Canada? Who noted that an unborn child would have representation before the courts by the Official Guardian were his inheritance rights in question, whereas the unborn child before an abortion committee has no personal or legal representation? Which MPs referred to abortionists appearing before a House of Commons committee promoting legalized abortion as "distinguished lawbreakers" and "the biggest gathering of criminal abortionists ever held in Canada"? This is a sad tale of enthusiasts guilty of betrayal, conniving revolutionists, timid fence-sitters, pro-lifers abandoning their courage. It is also the portrait of the on-going saga involving the highest levels of politics and religion. It is the story of pro-lifers valiantly following a rightly formed conscience to the end in their defense of the unborn and the incomparable Judeo-Christian truly just society.

Canadians were and still are deceived about the Charter but the book is full of confidence for the future, listing the many organizations and individuals who selflessly, and without state funding, continue to defend the unborn, the traditional family and the way of life which results when men and women build a society that acknowledges moral order. †

ONTARIO ORDERED TO RELEASE ABORTION STATISTICS

In 2012, the Ontario government secretly amended the Freedom of Information and Protection of Privacy Act (FIPPA) to prohibit release of any information on abortion. There is no recorded debate on this amendment in Hansard, nor were there any committee hearings held on it. It was quietly slipped into the law with no explanation. In effect, the Ontario government, by this amendment, buried all of its abortion information, hiding it from the public. If the public does not have any knowledge of what is going on in regard to abortion, how can the issue be discussed? That apparently was the purpose of removing all abortion information from government reports.

Ottawa pro-life blogger, Patricia Maloney, accidentally stumbled over this hidden amendment when she applied under the Act for information on Ontario's abortion statistics. She did not ask for personal information. All she asked for was information on how many abortions were being performed in Ontario, at what cost, at what stage of gestation, the age of the mother, and whether the abortion occurred in a hospital or clinic. She wanted this general information in order to engage in a public discussion on the issue. This was not too much to ask in a democracy.

When this information was refused, Ms. Maloney and the pro-life group, The Association for Reformed Political Action (ARPA), launched a legal proceeding in Ontario against the government for its failure to release the pertinent statistics. The legal arguments were heard in February, 2015 before Mr. Justice Marc R. Labrosse of the Ontario Superior

Court of Justice. In its legal challenge, the applicants, Ms. Maloney and ARPA, argued that the Ontario government was violating S. 2 of the Charter of Rights, which recognizes the rights of freedom of thought, the press, and expression, and that these protected rights carry with them a right to information. The Ontario government countered these arguments by stating that the secret amendment, S. 65(5.7), of the Act was to address its concern that the disclosure of such records by hospitals could pose risks to the safety and security of patients, healthcare providers and staff. What patients? Nobody asked for the names or addresses of the patients? How then was public safety an issue?

On June 9, 2017, Mr. Justice Labrosse handed down his decision, concluding that the Ontario government was violating S. 2(b) of the Charter in refusing to disclose this information. He stated that abortions were publicly funded, and, therefore, were a matter of public interest. He also stated that the Ontario government had provided no evidence as to why disclosure of these statistics would pose risks to the safety and security of patients, hospitals and their staff, as claimed by the government.

Mr. Justice Labrosse concluded that the refusal to disclose the abortion statistics by the Ontario government, under the FIPPA, was invalid. He gave the government twelve months to amend the Act. Should the government fail to do so, then the controversial provision secretly placed in the Act becomes automatically null and void. †

DEALING WITH OPIOID OVERDOSE DEATHS

Canada's approach to dealing with the opioid crisis is to establish more drug injection sites, pretending that they will reduce these deaths. Drug injection sites only provide a place for drug addicts to inject their illegal drugs. It has not been explained how these sites are supposed to curb drug overdose deaths since the sites cause the addicts to inject even more poison into their bodies, resulting in their inevitable and frequently terrifying deaths. Only 5% of drug addicts actually use these sites in any case. Most inject elsewhere as well, frequently several times a day, in alleys, behind buildings, in parks, etc. Even Minister of Health, Jane Philpott, a medical doctor, is confused by her own policy since she admits that she doesn't think the opioid crisis will stop any time soon, despite her scrambling to establish more injection sites across the country.

The U.S. is handling the opioid crisis more intelligently by taking no nonsense steps to stop the opioid deaths. U.S. states, counties and local prosecutors have commenced a wave of litigation against the pharmaceutical companies which manufacture the opioids that have caused the worst drug addiction crisis in history. The goal of this litigation is to turn Big Pharma into what was designated as Big

Tobacco in previous years.

That is, tobacco manufacturers were previously accused of deceiving the public about the addiction risk of cigarettes. The tobacco giants agreed in 1998, to pay more than \$200 billion (US) to the government toward the costs of providing health care for the resulting damage.

This same procedure is now being applied to the manufacturers of opioids. For example, the attorneys general of Ohio, Missouri, Mississippi and Oklahoma, plus counties in such states as California and New York are suing the drug companies for causing harm to the public. More lawsuits are probably coming. In all, twenty states have commenced legal action against the drug manufacturers.

The U.S. authorities are arguing that the opioid epidemic was produced by a fraudulent scheme to mislead doctors and the public about the need for and the hidden addictive nature of opioid drugs. The authorities also argue that the pharmaceutical companies put millions of dollars into advertising and sales in order to increase the consumption of opioids, while also encouraging legislation that has made opioids even more readily available to the public.

One of the primary targets of these lawsuits has already

admitted its fraudulent behaviour. Purdue Corporation, which manufactures OxyContin, pleaded guilty to criminal felony in 2007, agreeing to a \$600-million settlement in the US, admitting that it had inaccurately promoted the product-between 1995 and 2001-as being less addictive than other opioids, which was not true. Purdue has further offered \$200 million to settle a class action lawsuit against it in Ontario. Other drug companies charged are the manufacturers of Percocet, Opana, and the generic drug Oxycodone. Opana is manufactured by the Dublin Ireland company ENO and it expects to pay \$20 million in damages as its opioid has become a favourite of addicts who no longer crush and snort the pill, but now inject it, leading to a serious outbreak of HIV and Hepatitis C.

NON PRESCRIPTION OPIOIDS

There is another problem with opioids in that nearly 70% of opioid deaths do not come from prescription abuse, but rather, come from illegal opioids such as heroin, illegal fentanyl and a hundred other cheap street drugs made in kitchen pharmacies. They contain questionable components and uncontrolled strengths triggering unintended overdosing by addicts.

As a result, US Attorney General Jeff Sessions, recently announced the appointment of 12 prosecutors to investigate health care fraud and opioid scams that are fuelling the drug overdose epidemic in the US. If only Canadian authorities had such common sense.

In B.C., it was found that the drugs used in 60% of overdose deaths and 86% of drugs brought into Vancouver's drug injection site were contaminated with fentanyl. Drug traffickers in Vancouver can easily order this highly potent, low-cost drug online, mainly from China. It is then cut into small portions to sell on the streets. The contaminated drug is then purchased by addicts, who bring this illicit drug for use in supervised injection sites or inject it elsewhere.

What we should be doing is working towards prevention of drug use. Addiction is preventable if we apply strong law enforcement, as well as education to tell the public the direct message that drugs are deadly. Youth have to understand that the use, not only of opioids, but also alcohol, tobacco and marijuana, is a grave risk to their lives. 90% of addiction starts with the use of these latter substances.

Instead of agreeing to stop overdose deaths by law enforcement and education in Canada, a coalition of drug users, harm reduction workers and the Canadian HIV/AIDS Legal Network, among others, are calling on the government to legalize all hard drugs and give access to prescription heroin. They claim drug prohibition is exacerbating the drug crisis. They argue that addicts will stop using dangerous street drugs and committing crimes if only they have a safer alternative.

These activists have been encouraged by statements made by Dr. Eileen de Villa, Toronto Medical Officer of Health, and NDP Toronto City Councillor, Joe Miheve, Chair of the Board of Health, who support the legalization of drugs on the basis that it curtails deaths by making it easily accessible. Just how this is supposed to happen has not been explained.

One hopes the federal government does not cave in to such bizarre claims. It will only lead to increased deaths by drug overdose. The opioid problem costs the taxpayers billions of dollars annually in providing emergency health care to addicts, and in picking up the pieces of destroyed lives. It is also causing a depleted work force among primeage workers. In the US at least 25% of work applicants fail the drug tests or are deterred from even applying for jobs. This is resulting in thousands of unfilled jobs.

The only beneficiaries of the drug epidemic are the drug industry both legal and illegal, and also those workers serving addicts as care councillors providing them with social services. *
